






- Switching to 100% renewable energy at our Brixton site alongside supporting remote workers to find renewable options for their homes.
- Switching to an award-winning sustainable waste management vendor to weigh and track our waste in Brixton.
- Obtaining Albert certification for a production

Provided training delivered in:


- Mental Health, Health and safety, Fire safety and First aid
